RAPID REHOUSING SERVICES SUPPORT HOUSEHOLDS WHO ARE RECENTLY HOMELESS IN QUICKLY GAINING ACCESS TO HOUSING. FINANCIAL ASSISTANCE IS PROVIDED FOR SECURITY DEPOSIT, MOVE-IN FEES, RENT AND UTILITIES.
